It was found that the correct permits for a hunting cabin were purchased and obtained prior to build. Hunting cabin appears to meet the township's current requirements. Zoning needs to be addressed as this property appears to be zoned Resource Preservation (RP-1) and is currently only a 10 acre parcel.
