A valid permit may be renewed one time upon approval from the Recreational Zoning Administrator and with state valid prequalification documentation. Renewal must be filed with the Recreational Marijuana Administrator (RMA) at least 30 days prior to the date of original permit expiration.

Further, I understand this is a Recreational Marijuana permit which conveys land use rights and does not include any representation of conveyance of rights in any other statute, building code, deed restriction, or other property rights.

- A written sign plan specifying the locations, size, and lighting of any proposed signs to be placed on the property or buildings of each type proposed marijuana establishment.
- Documentation from the Michigan Marijuana Regulatory Agency that applicant has been granted prequalification status from that Agency for the state operating license needed to operate each marijuana establishment(s) that is the subject of the application.
