	Agricultural Building:	\$150 per 1000+ sq' (must meet Agricultural definition)
	Decks:	\$10 per 100 sq' (length x width)
	Fence:	\$10 per 100 sq' (length)
	Pool: (larger than 48 sq')	\$50 (Above ground) / \$100 (Below ground)
	Solar Panels: (personal use)	\$100 for every 6 panels
	Temporary Use:	\$50
	Marijuana Permits:	See permit application for fees

Costs incurred for any other special meetings and any other extra costs including excess attorney fees will be billed to the applicant.
